## CHARGES FOR DEBT RECOVERY

### INITIAL LETTER:

For a once off letter we charge €30.00 plus reduced commission of 3%.

Fees for volume or special transactions are negotiable.

### BASIS OF CHARGES:

Basic Fee + Recoverable \ Scale Costs + Commission + Outlay.

Commission is only charged if money is recovered. In a successful case you can expect to pay only the basic fee and the commission as the debtor must pay the scale costs.

### 1. BASIC FEE:

## 2. RECOVERABLE\SCALE COSTS:

#### **JUDGMENT MORTGAGES:**

€600.00 plus Land Registry Fees of €125.00 and stamp duty of €50.00 or taxed costs whichever is the greater. These costs are recoverable from the debtor.

## **GARNISHEE/FREEZING ORDERS**

Fees are quoted on an individual case. Basic minimum fee €1,000.00 plus outlay. Can be recovered in part or in full.

## **BANKRUPTCY AND LIQUIDATION:**

Fees quoted on an individual case basis.

## **EXAMINATION OF DIRECTORS:**

Fees quoted on an individual case basis – minimum fee €2,000.00

## **OUTLAY:**

Additional Outlay may be incurred i.e. Stamp Duty, Agent's Fees, Enquiry Reports, Service Fees, Search Fees, Counsel's Fees, Travel.

## **DEFENDED CASES:**

There will be some non-routine cases which require special attention and additional input, e.g. disputes, settlement negotiations, instalment arrangements, multiple adjournments.... Some other cases may go to a full hearing before a Judge. The fees in these cases shall be charged on the basis of work carried out and outlays incurred.

## **MISCELLANEOUS:**

1. All above costs are exclusive of V.A.T. (currently 23%) and Outlay.
2. Where instructions are received to discontinue proceedings costs will be charged on the basis of work done to date.
3. Credit Terms - 7 days from date of Invoice.
